Biography

I graduated from the University of Rome, Italy, in 1989 with a degree in Psychology. In 1993, I completed my Ph.D. with a work entitled “A circumplex hierarchical approach to taxonomies of personality characteristics” at the University of Rome La Sapienza, Department of Psychology. Following this, I have been Research associate in Psychometrics for two years at the Department of Social and Developmental Psychology, University of Rome La Sapienza, before becoming Researcher (equivalent to Lecturer) in the same Department in 1995. In September 1998 I moved to the United Kingdom where I was a Lecturer in Social Psychology at the Department of Psychology of the University of Leicester. I joined the Department of Psychology at the University of Essex as Senior Lecturer in October 2000 and subsequently as a Reader (2003) and then as a Professor (2006). From October 2006, I am at the Department of Psychology of the University of Milan-Bicocca with a chair in Psychometrics. I have been Head of the Department of Psychology (2013-2017) and Deputy Head (2017-2018) and Director of the PhD program in Psychology, Linguistics, and Cognitive Neuroscience (2019-2022).

Main research interests

Research interests span the various fields of personality, social psychology, and experimental psychology, with a keen eye on methodological and psychometric issues. They are part of a broader interest in individual differences, personality traits, attitudes, social cognition, and in the factors that underlie evaluation and motivation and influence behavior, as well as in the relevant quantitative methods and techniques.

In personality, the interests are on general taxonomies of broad personality dimensions (so-called Big Five and Big Six) and on the development and application of implicit measures. My interests focus also on the role of individual differences in automatic behaviour within a broader dynamic situation-person interaction perspective. I have recently focused my research on Conscientiousness and its modeling using network analysis. The use of network analysis as a statistical and theoretical tool brings to a new conceptualization of personality traits as relatively stable equilibria in a network of interacting behaviors, thoughts, feelings, affects, and motivations. This new conceptualization opens up the possibility of expecting personality traits change if central nodes in the network are systematically perturbed.

My background in Psychometrics and quantitative research methodology is the cornerstone supporting all theoretical interests. Most statistical methods are applied and refined depending on the specific needs. I have been involved in the replicability debate in Psychology since its beginning and I have authored several publications on related issues, including on power analysis. I have also co-organized an early international expert workshop on replicability in Psychology with leading researchers from most psychological fields.

Another research interest is in developing, applying, and testing models of decision making within the tradition of attitude theory and social cognition, with a recent focus on the measurement and the interplay between implicit and explicit attitudes and on the moderators of their predictive validity. A related research interest is on behavioral change, initially concerning health and environmental-related behaviors, which dovetails nicely with the interest in personality trait change.

Further research interest is in evaluative learning and the use of related paradigms as a means to change implicit and explicit attitudes. For example, the use of one such paradigm (the Self-Referencing task) proved successful in several studies to change implicit and explicit attitudes towards a range of targets (e.g., consumer brands, social groups) and led to the recent discovery of a previously undetected basic learning principle (i.e., intersecting regularities). A recent research direction is in considering also the role of personality traits, for example Neuroticism, in affecting evaluative learning, such as evaluative conditioning.

Finally, a recent interest is in the use of inferences by people, such as when they extrapolate some features about one concept target given some features of a concept source and some, even superficial, commonalities among the two. This broad conceptual idea is encapsulated by the recently developed Feature Transformation Effects framework, to which I have contributed. For instance, I have contributed to recent research on halo effects, such as the organic halo effect, and how they can influence inferences not only on some unrelated qualities of the same target concept but also of a different target concept (e.g., person perception).

Given my broad scientific interests, I am also involved in several international collaborations on a range of topics with colleagues from several countries (e.g., USA, UK, Germany, Belgium, France).

- I have been author or co-author of almost 200 publications, including 24 among books and chapters of books. Most publications are in international journals and over 160 are listed in Scopus.
