- **Having regard to** the Rector's Decree no. 0032642/22, of 15 April 2022 by which the admission to the XXXVIII cycle of the PhD programs of Milano-Bicocca University has been held;
- **Having regard to** art. 2 of the aforementioned Decree that establishes the Session II, dedicated to positions activated on PNRR actions, with publication dates of the postions from 15 July 2022 to 29 July 2022;
- **Having regard to** the Ministerial's Decrees 351 and 352 of 9 April 2022 which have allocated respectively for the academic year 2022/2023, from the PNRR, Mission 4, component 1, Investment 3.4 and Investment 4.1, 35 three-year PhD scholarships to attend PhD programs and, always from the PNRR, Mission 4, component 2, Investment 3.3, 79 scholarships to be 50% cofunded by Businesses, for XXXVIII cyde, academic year 2022/2023
- **Having regard to** the establishment of three new doctoral programs for XXXVIII cycle that offer the PNRR scholarships assigned to the University under Ministerial Decree 351 of 9 April 2022;
- **Having regard to** the above mentioned Doctoral programs that are "Intangible Heritage in Socio-Cultural Innovation", "The New Public Administration: data and human resources", "Marine Sciences, Technology and Management (MTM)" and that these programs are in the associated form under art.3, paragraph 2, Ministerial Decree 226/2021;
- **Having regard to** the resolution of the Board of Directors no. 595/2022, in the session of 5 July 2022, relating to the establishment of three new doctoral programs XXXVIII cycle that assignes the PNRR scholarships allocated to the University from Ministerial Decree 351. The same resolution of the Board of Directors states the consistency evaluation concernig the PhD scholarships with the topics linked to Ministerial Decrees 351 and 352 of 9 April 2022;
- **Having regard to** the agreements for cofunded scholarships ex Ministerial Decree no. 352 of 9 April 2022;
- **Given that** the proposing Head of the Area certifies the regularity and legality of this act;

HEREBY DECREES

Article 1 (Publication of positions Session II)

For the reasons indicated in the premises of this provision and which are hereby understood to be fully reported, the publication of the Description sheets XXXVIII cycle Session II attached to the Call for Applications Protocol No. 0032642/22 of 15/04/2022 with the positions announced.







Article 2

(Provisions of the Call for Applications)

All the provisions of the Call for Applications D.R. n. 0032642/22 of 15/04/2022 with which the competition for admission to the XXXVIII cycle of the PhD courses with administrative headquarters at the University of Milan-Bicocca was called is considered to be recalled and valid except for what is specifically regulated in this decree.

Article 3

(Expression of interest in PhD scholarship positions for the project "Intangible Heritage in Socio-Cultural Innovation", "The New Public Administration: data and human resources" and "Marine Sciences, Technology and Management")

3.1.Candidates must express at least one preference for the scholarship positions for the project indicated in the call for applications by completing the questionnaire, as defined in Article 6 of the Call D.R. n. 0032642/22. This preference will be considered as a mere expression of interest and will not be binding.

The candidate must upload at least one project as required by Art. 4 of the Call D.R. n. 0032642/22.

3.2 For the purposes of awarding the scholarships, without prejudice to the provisions of Artide 12 of the notice D.R. n. 0032642/22 of 15/04/2022, the Selection Board may decide to assign a project scholarship to a candidate for which he/she has not expressed an interest during registration, based on the overall assessment of the candidate.

Article 4

(Expression of interest in project scholarships under Ministerial Decree 352)

4.1 For positions under Ministerial Decree 352 in collaboration with the Companies, candidates may submit applications for a maximum of 2 positions, also referring to different courses.

For these positions, in addition to the provisions of Art. 4 of the notice D.R. n. 0032642/22 of 15/04/2022, it is necessary to upload the research project relating to the topics of the chosen position, using the model referred to by the link in the Description Sheet (Annex Description Sheets XXXVIII cycle - Session II).

It is necessary to present a specific project for each of the scholarships chosen under the DM 352.

4.2 The positions under Ministerial Decree 352 will be allocated as follows, without prejudice to the provisions of art. 12 of the notice D.R. n. 0032642/22 of 15/04/2022:

- if the candidate is eligible for two scholarships, he/she will be included in the respective ranking lists based on the score obtained.
- the Selection Board also reserves the right to assign a candidate who results to be eligible and not an assignee, to a scholarship not chosen at the time of registration, provided that it is part of the same course, based on the overall evaluation of the candidate.

Article 5

(Obligations of the PhD student)

The submission of the application for admission to the competition through the Online Registrar Office according to the procedures referred to in art. 4 of the Call D.R. n. 0032642/22 of 15/04/2022 entails, under penalty of exclusion, the commitment by the candidate:

 to carry out the required research periods in the company or at an institution and abroad following the chosen project, and as indicated in Ministerial Decrees 352 and 351 of 9 April 2022;

<u>Note:</u> In the event of any inconsistency or discrepancy between the English version and Italian version of this Call, the Italian language version shall prevail.

- to report on the activities carried out following the provisions of Ministerial Decrees 352 and 351 of 9 April 2022;
- to respect the principle of not causing significant damage to environmental objectives, under Article 17 of Regulation (EU) 2020/852, and to ensure consistency with the PNRR positively assessed by the ECOFIN Council Decision of 13 July 2021;

Article 6

(technical registration procedure)

During the registration phase of the competition for all the positions of Session II, once the online application has been completed, it will no longer be possible to modify or cancel it. While entering the application, and before the final confirmation, it will always be possible to cancel it and redo it completely.
