



THE RECTOR

Having regard to the D.R. n. 0032642/22 of 15/04/2022 with which the competition for admission to the XXXVIII cycle of the PhD Programmes with administrative headquarters at the University of Milan-Bicocca was called;

Having regard to the art. 2 of the aforementioned decree that provides for Session II, dedicated to positions activated on PNRR shares, with opening dates for applications from 15 July to 29 July;

Having regard to the D.R. n. 4652/2022 Prot. n. 0067378 of 03/07/2022 relating to the publication of the Description sheets XXXVIII Session II cycle;

Having regard to the D.R. n. 4941/2022 Prot. n. 0074193 of 03/08/2022 which provides for the addition to the Admission Nitoce to the XXXVIII cycle of the PhD Programmes mentioned above, of Session III, dedicated to the positions activated on the PNRR actions of Mission 4 Component 2, National Centres, Ecosystems of Innovation, Research Infrastructures and Extended Partnerships, and to positions in collaboration with partner companies of the aforementioned PNRR projects with opening dates for applications from 03 to 17 October 2022;

Given that the proposing Head of the Area certifies the regularity and legality of this act;

HEREBY DECREES

Article 1

(Publication of positions Session III)

For the reasons indicated in the premises of this provision and which are hereby understood to be fully reported, the publication of the Description sheets XXXVIII cycle Session III attached to the Call for Applications Protocol No. 0032642/22 of 15/04/2022 with the positions announced.

Article 2

(Provisions of the Call for Applications)

All the provisions of the Call for Applications D.R. n. 0032642/22 of 15/04/2022 with which the competition for admission to the XXXVIII cycle of the PhD courses with administrative headquarters at the University of Milan-Bicocca was called is considered to be recalled and valid except for what is specifically regulated in this decree.

Article 3

(Submission of application for admission and deadlines)

The application for admission must be submitted **no later than the mandatory deadline** indicated below:

Session III	17 October 2022 h. 12:00 (Italian time)	1st January 2023

Note: In the event of any inconsistency or discrepancy between the English version and Italian version of this Call, the Italian language version shall prevail.



Those enrolled in Session I and Session II positions may not participate in the selections of Session III. These subjects, if enrolled in Session III, will be excluded from it automatically after registration.

For courses that require the submission of letters of reference, art. 4 Notice Protocol No. 0032642/22 of 15/04/2022, the upload must take place by **18 October 2022**.

The payment of the expenses contribution of € 10.00, art. 4 Call Protocol No.0032642/22 of 15/04/2022, must be made by the dates indicated below under penalty of exclusion from the selection procedure examinations:

Article 4

(Obtaining the qualification extension)

Notwithstanding the provisions of Article 3 of the Call Protocol No.0032642/22 of 15/04/2022, graduates may also apply for Session III provided that they obtain the degree by 30 November 2022 under penalty of forfeiture.

Article 5

(Expression of interest in project scholarships)

5.1 Candidates must express at least one preference and up to a maximum of two for the project scholarships indicated in the Notice for each Program they intend to enroll by selecting the acronym of the project(s) of interest at the time of registration for the competition. Such preference(s) will be considered as mere expressions of interest and will not be binding.

5.2 The candidate, if requested by the Program Description Sheet, must upload at least one research project as required by Art. 4 of the D.R. notice no. 0032642/22.

5.3 The Description Sheet for each Program, an integral part of the Notice, indicate whether it is possible to choose projects belonging to different curriculum or, alternatively, whether it is possible to choose projects relating to only one curriculum within a Program.
The possibility of enrolling in more than one PhD Program remains unchanged.

5.4 For the purposes of awarding the scholarships, without prejudice to the provisions of Article 12 of the DR notice no. 0032642/22 of 15/04/2022, the Selection Board may decide to assign a project scholarship to a candidate for which the candidate has not expressed an interest during the registration phase but for which he/she is assessed as suitable by the Selection Board, based on the overall evaluation of the candidate.

In any case, the award of an unchosen scholarship must take place within the same Program and, if only one curriculum is chosen during the registration phase, within the same curriculum.

5.5 The allocation of the scholarships, if the ranking is scrolled, will be based on the assessed suitability for the project scholarships and not on the score obtained.

5.6 In the event of equal scores, gender balance is considered, that is, the gender prevailing among the candidates placed in a higher position in the same ranking is a minority. In case of further equality, the less senior candidate prevails.



5.7 The reassignment of vacant positions if any of the registered students waives or lapses from admission to the Program will be carried out no later than 13 December.
If a candidate is offered a Session III position and one of the previous Sessions simultaneously as a result of scrolling, the candidate must decide which one to accept.

Article 6 (Assignment of positions)

The competition procedure ends with the award of the scholarships to the winners, which must take place no later than 31/12/2022.

Article 7 (Selection Boards)

The competition Selection Boards appointed for the XXXVIII Session I cycle remain unchanged for Session III unless modified.

If there are several subcommittees on a single course, they will be activated only in the presence of scholarships related to the related curriculum.

For courses that in Session III, unlike Session I, do not ask candidates to choose between the curriculum present during the registration phase, single committees will be appointed.

Article 8 (Technical registration procedure)

During the registration phase of the competition for all the positions of Session III, once the online application has been completed, it will no longer be possible to modify or cancel it. During the entry of the application, and before the final confirmation, it will always be possible to cancel it and proceed to a new compilation.
