- HAVING REGARD TO** R.D. prot. n. 0151522 and prot. n. 0151567 of 20/03/2025, by which the calls for applications for admission to the XLI cycle of PhD programmes, with administrative headquarters at the University of Milan-Bicocca, were announced;
- HAVING REGARD TO** R.D. prot. n. 0155969 of 26/03/2025, which supplemented the information regarding the research projects listed in the call description sheet attached to the decree activating the PhD programme in Strategic Innovation for Sustainable and Smart Ecosystems;
- HAVING REGARD TO** Article 2 of the aforementioned decree and the premises of the call for the PhD programme in Strategic Innovation for Sustainable and Smart Ecosystems, which provide for Session II of the call, dedicated to positions activated in collaboration with companies, with application opening dates from 11 July to 24 July 2025;
- GIVEN** that additional funds have been made available by companies and external entities to finance PhD scholarships and executive positions for the XLI cycle of PhD programmes, and that specific agreements have been signed with these entities;
- GIVEN** that the PhD programme in "Resources for the New Public Administration: People and Data" will be included in the second session of the call, with the application opening dates as indicated above;
- GIVEN** that the possibility of an additional decree to increase the total number of positions offered for selection is provided for, to be issued by the call deadline;
- GIVEN THAT** the proposing Head certifies the regularity and legality of this act;

HEREBY DECREES

Art. 1

(Publication of positions Session II)

For the reasons specified in the premises of this decree, which are considered fully incorporated herein, the publication of the "XLI Cycle Session II Call Description Sheets," attached to this Decree and indicating the positions offered, is hereby proceeded with.

Art. 2

(Call Provisions)

All provisions outlined in the calls, D.R. prot. n. 0151522 and prot. n. 0151567 dated 20/03/2025, are considered referenced and valid, except for what is specifically regulated in this decree.

Note: In the event of any inconsistency or discrepancy between the English version and the Italian version of this Call, the Italian language version shall prevail.

Art. 3
(Selection sessions)

The increase in PhD scholarships may lead to an increase in the total number of positions available for competition. These additional positions will be announced through a subsequent decree, forming an integral part of the call, which will be published by the Session II deadline on the webpage: <https://en.unimib.it/study/doctoral-research-phd-programmes/applying-doctorate>

Art. 4
(Project-based, topic-based and advanced training apprenticeship positions and scholarships)

Should project-based scholarships be listed on the course description sheet, candidates may indicate up to two preferences by completing the questionnaire on the application platform, specifying the scholarships they wish to apply for, and uploading the research project, which may relate to one of the scholarships of interest.
