# **BUSINESS AND CONSUMER CONTRACTS IN A GLOBAL PERSPECTIVE**

LECTURER: CERINI DIANA VALENTINA

## **CONTENTS**

After an introduction to the essential aspects and methodology of comparative law, the European law models will be examined, with specific reference to harmonization, unification and optional law models. A particular focus will be dedicated to business-to-consumer directives and their implementation in the Member States.

The course will also examine business and consumer contract law and models outside the Western Legal Tradition. In particular, contract law and models in BRICS countries will be considered.

The second part of the course will address specific issues relating to the formation of the contract and its effects, namely unfair commercial practices and misleading advertising in business-to-business contracts, unfair terms, sale of goods liability for defective goods.

Finally, specific contracts will be examined, with particular reference to the financial sectors, credit contracts and insurance contracts.

The aim of civil justice, i.e. to guarantee an effective protection of rights within a reasonable time (and, of course, at reasonable costs), cannot be pursued through the same model of procedure. Focus of the course is to point out the essential features of different models of procedure adopted in Europe as well as in the United States.

Lessons take into account the principles and the main features of: i. Italian Civil Procedure; ii. English Civil Procedure; iii. U.S. Civil Procedure.

At the end, the course will turn to the main trends and policies which have been raised from the analysis of the above mentioned systems.

Foreigners students are welcome to compare one or more topics of the course with their respective legal systems.

The course, which will be mainly focused on the analysis of the Commission's common practice and ECJ's case law, including well-known cases involving undertakings such as Microsoft and Google, will offer a very practical overview of the functioning of the Internal Market and, in particular, of EU competition law, through the analysis of competition rules applicable to the private field (anti-competitive agreements, abuse of dominant position and mergers ex art. 101-106 TFUE), as well as rules governing public intervention in the economy (State aid rules, liberalization policies ex art. 107 and 108 TFUE).

## EUROPEAN UNION COMMON AND SECURITY DEFENSE POLICY

### CONTENTS

The course aims at consolidating the knowledge of the institutional and structural aspects of the European Union, as well at enhancing the comprehension of the role of played by the Union in the field of the maintenance of peace and security.

The following issues will be covered: The basic features of the EU's external relations regime; The institutional aspects of the CSDP and its integration into the EU legal order; The CSDP missions carried out by the EU, their classification, structure and functions; The operational solutions adopted at EU level in order deal with legal implications of these missions (i.e., rules of engagement, human rights protection in the territories where the EU is present, the distribution of responsibility between the EU and its Member States for the activities carried out); The applicability of international humanitarian law to CSDP operations; The EU as a regional agency in the sense of Chapter VIII of the UN Charter and its relationship with the UN Organization.

The course focuses on three of the legal pillars of modern economies: corporations, bankruptcy and insurance.

By combining history and economic analysis of law, the course is aimed at exploring the foundations on which these institutions have been built, in order to allow students to acquire a more solid knowledge and a more critical understanding of their current regulation across modern legal systems.

The course begins with an introductory part, aimed at setting the stage for the application of both historical and economic analysis of those topics. Then three parts follow, each one devoted to the study of each legal institution, by going through its historical development, as well as by reflecting on its economic rationales.

## INTERNATIONAL AND COMPARATIVE CORPORATE TAXATION

### CONTENTS

This course offers a comparative analysis of various solutions that are adopted by several tax systems as a response to increasing common international tax problems of their corporate income tax systems.

First, the basics of international taxation will be explained. Second, the common core of tax systems of industrialized countries in relation to basic corporate domestic and international tax problems will be identified. Third, different corporate tax models (and their circulation) among different countries will be analyzed. Finally, a closer look at the US and Italian corporate tax mechanisms for the resolution of the tax problems discussed earlier in the course will be taken.

# INTERNATIONAL PEACEKEEPING AND UNITED NATIONS LAW

## CONTENTS

The course outlines the basic legal features of the UN system of collective security and specifically deals with one of the main tools elaborated by the UN Organization for the maintenance of international peace and security, namely peacekeeping operations. Originally conceived in the Cold War as neutral and consensual-based instruments alternative to coercive measures involving the use of force, peacekeeping operations have substantially evolved through the years, in order to respond to very enlarged and diversified tasks, such as the protection of civilian populations or state-building functions in countries ravaged by internal armed conflicts. The course aims at exploring the evolution of peacekeeping operations in both its legal and operational aspects.
