Candidates must enroll no later than 13 november 2020

Applicants who do not complete the enrollment by the deadline indicated above loose the right to admission.

In order to enroll, the admitted candidates must follow these steps within the due date:

- 1. log in the segreterie on line and fill in the on line enrolment form (from the right drop down menu, select home>enrollment>enrollment to restricted access courses);
- 2. pay the first installment of the tuition fees, using the pre-filled PAGOPA form, that is printable at the end of the online enrolment procedure;

If the payment is to be made by third parties (e.g. companies, entities, etc.) other than the candidate,

 $they \ can \ request \ the \ issuance \ of \ a \ debit \ note \ by \ sending \ an \ e-mail \ to \ ufficio. master @unimib.it \ specifying \ their \ company \ name \ and \ Vat \ number.$

It is also possible to pay directly through bank transfer, using the bank account indicated in the call (art.4)
