

COMMUNICATION ABOUT NEW MEASURES ADOPTED BY THE UNIVERSITY OF MILAN-BICOCCA CONCERNING STUDENTS WHO ARE ENTITLED TO RECEIVE DSU BENEFITS AND STUDENTS USING UNIVERSITY'S RESIDENCES

1) Meals

Students who are currently staying in University residences located in Milan, Sesto San Giovanni and Cinisello are entitled to receive free lunches delivered to the residence until the 3rd of May included. The University shall give notice of any postponement.

Students who reside outside University residences can use the University canteen which is located in U6 and it is open for lunch. The canteen service is administered in full respect of health precautions.

2) Housing services

Housing services provided by the University residences are extended at no cost until the 3rd of May 2020 for students who could not leave them, including those for whom the DSU status is expired. No communication from the student is necessary. The University shall give notice of any postponement.

3) Remodulation of scholarships and of tariffs paid by students who are not entitled to DSU benefits

Considering the current emergency, and in accordance with the guidelines provided by ANDISU, the University has decided not to apply the criterion of a minimum duration of the valid onerous qualification (registered rental contract, Erasmus contract with receipts, private facilities, university accommodation). Therefore for the acadamic year 2019/2020 the following rules will be adopted.

For scholarship students who are *fuorisede* in the final scholarship ranking, but who do not meet the requirement foreseen in the definition of the *fuorisede* condition, the scholarship is remodulated as follows:

- a) the amount due is equal to the sum of the *pendolare scholarship* for the student's group plus an amount corresponding to 1/10 of the difference between the amount from *fuorisede* and *pendolare scholarship* multiplied by the number of months of valid onerous qualification (registered rental contract, Erasmus contract with receipts, private facilities, university accommodation);
- b) the students entitled to stay in the University's accommodation facilities will pay the corresponding deduction only for the months of actual use, with the exception of the free months granted by the University for the health emergency (see previous point 2).

The University will finalize the remodeling on the occasion of the payment of the second installment. No communication from the student is required.

For non-scholarship holders, the rate for the use of housing facilities will not be applied for periods of absence which began between February 1 and March 22, 2020 and still ongoing until 3rd of May 2020 or until the expire of the occupation entitlement, if prior to 30 April 2020. Other periods of

absence will be assessed on request and must be justified with documentation proving the legitimate reason for the move from the University's accommodation facilities.

4) Failure to release or to use the University housing facilities after the deadline

The University will pay the custody contribution due by students for whom the term of use of the University housing facilities expired during the period between 1 February and 3 May 2020 but who have not had the opportunity to vacate the housing facility or who have not been able to take possession of the housing facility in which they intended to stay as a foresteria.

5) Further initiatives

As regards the verification of the merit requirement, a special provision of the Ministry is being prepared and we will promptly notify. Further initiatives in favor of students will be decided in coordination with the Region and with other Lombard universities, taking into account the need to ensure contractual balance and ensure the sustainability of the University's economic and financial balance.
