PROGRAM DESCRIPTION

MSc. Degree in International Economics offered by the Department of Economics, Management and Statistics at the University of Milano-Bicocca is a two-year study program that provides advanced knowledge and skills in core areas of economics achieved through the delivery of advanced courses in macroeconomics, microeconomics, international economics, econometrics and other range of optional courses (Game theory, European studies, Industrial organization, Labor economics). In order to give an in-depth exposure to the various theoretical constructs, the students are also required to attend courses in management, corporate finance, business strategy as well as European and international contract law, competition law and employment law. The overall aim of the course is to train students for careers as applied economists in the private sector as well as in government and international organizations.



CAREER PATH

The program trains students for a career as applied economists in the private sector as well as in government and international organizations. Our alumni are working as junior economists, business analysts, policy advisors and researchers in large companies, financial institutions, government and international organizations.

The program also provides a strong foundation for undertaking doctoral studies. Our alumni apply successfully to Italian and International doctorate programs.
