# HEREBY DECREES

### Article 1

# Article 2

In consideration of the timing of the issuance of the residence permit for temporary protection pursuant to the Prime Ministerial Decree of 28 March 2022, if the candidate is not yet in possession of the residence permit at the time of registration and by the end of the Call Session, the candidate may upload the receipt of the residence permit application. The candidate, if assignee of a position, will enroll under condition. The title to be submitted shall be as follows:

- Residence permit for temporary protection pursuant to the Prime Ministerial Decree of 28 March 2022.
